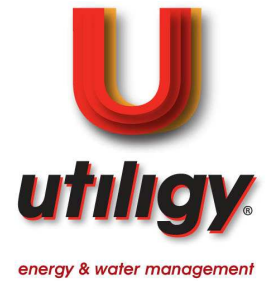

### Record orders continue

Intermoco Limited (ASX:INT) (Intermoco), a leading provider of energy and water management solutions through its Utiligy brand, is pleased to announce that the company has continued to receive a strong flow of orders for its metering and communications technology. Following on from a record amount of orders in April 2009, the company received \$600,000 worth of orders in May 2009 which brings the past 12 week order intake to approximately \$2 million.

As part of this recent strong operating performance, Intermoco has signed contracts with 3 new embedded networks.

The 3 new contracts are with:

- Hollywood Hospital, Perth
- Brighton Apartments, Perth
- Port Stephens Council, NSW

This takes Intermoco's total number of embedded network customers to 100, with another 4 contracts expected by the end of June. In addition, there are now 15,800 meters under Utiligy management which is expected to be over 16,000 by the end of June.

Intermoco Executive Chairman and Chief Executive Officer, Mr Bob Gestro said the signing of these 3 new contracts was a significant achievement for the company.

"As part of the business plan that we developed earlier in the year, we set 6 month targets of 100 embedded networks and 15,000 meters. The fact that we have achieved these targets well ahead of schedule is a strong endorsement of the Utiligy solution"

An embedded network is an electricity, gas or water supply system downstream of a utilities main meter that is billed by Utiligy on behalf of the network owner, normally building owners, body corporates or building managers.

Utiligy is now looking to introduce the reselling of energy and complete its offering with the addition of voice and data products through its strategic Partnership with NEC. The reselling of electricity, voice and data is expected to significantly increase the Company's revenues within those embedded networks that are converted to the reselling model.

Utiligy and NEC are currently working on the first of these properties for a 17 storey building in Melbourne's CBD which is expected to be announced later in the year.

Mr Gestro said "Achieving our targets well ahead of schedule not only delivers additional orders in FY2009, it is also indicative of the strength of our order book for FY2010 and beyond. The signing of these new contracts shows the business is continuing to grow. Utiligy's world leading technology and our strong position in embedded networks will further underpin the company's ongoing expansion."
